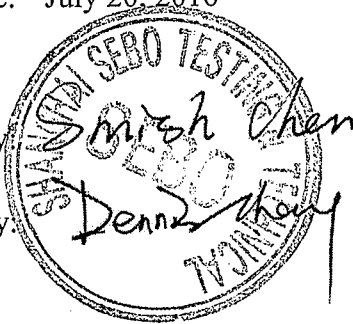

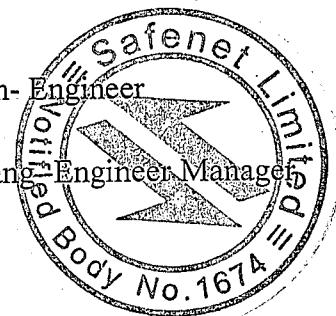

## Part I: Introduction

### Spill Pallets:

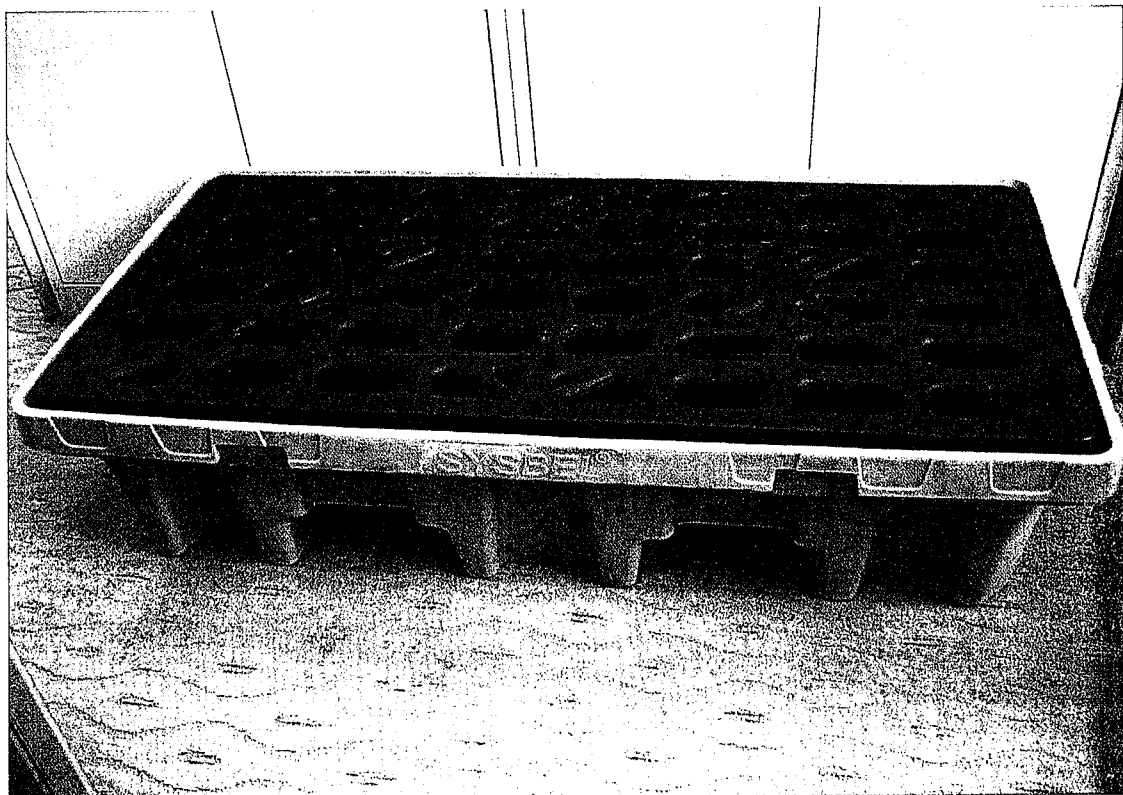

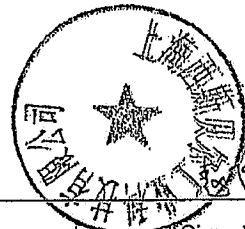
